Kitchen Personnel	\$10.00 per hour in addition to above

Groups and individuals renting the Unionville-Sebewaing Area facilities are to pay the above directly for their services. A separate rental payment is to be made to the school district in accordance with the above Rental Agreement.

All persons or organizations desiring to use school facilities are requires to complete the Rental Agreement Form and return to the Office of the Superintendent of Schools at least five days prior to the date facilities are to be used. All renters are requested to observe all rules and regulations. Failure to comply may result in the denial of future requests.

The Board of Education may require that a custodian be on duty when school building is used. The Board also requires a technology support person be in attendance when the auditorium is rented. The Board also recommends that a cafeteria employee be employed whenever refreshments or a banquet require the use of a school kitchen. The employee is not required to wash dishes or operate the dishwasher.
